



## Outagamie County Fair Century Farm or Home Application Requirements for Award

### **Only one certificate will be issued per property:**

For example, a descendant may not receive another certificate if a former owner or relative has already received a certificate for the same property.

### **Continuous family ownership of property for 100 years:**

The farm or home (in whole or in part) must have been in continuous family ownership. Title of the Century property today must reside in a blood relative of the original owner, or a legally adopted child of a descendant. Continuous residence in the state or on the property is not required, but the title to the property must be continuous. An abstract of title is the best evidence of continuous family ownership. Please do not send valuable documents to our office.

### **Recognition:**

Farms or homes with 100 years of continuous ownership through the current fair year, will be recognized on Sunday during the fair at 2 p.m.
