Outagamie County Fair - Winter Storage Schedule		
Agreement and payment due	October 1, 2019	Last year's customers must have agreements and payments in by October 1 to reserve storage space. We accept new customers late returned agreements if space is available.
Storage In	October 19, 2019 7:00 AM – Noon	Exceptions may result in additional fees.
Storage Out	April 18, 2020 8:00 AM	Property not removed on the "Storage Out" date may incur a removal fee of \$20.00 plus \$.50/ft per week as determined by OCF.

Reminders

- Bring all storage items through the County Fair Street gate. Exit through west gate (Henry St).
- Check-in each item and attach number tags.
- Do not leave any items without completing check-in.
- Legibly print your first name and phone number on the provided luggage tag or I.D. card and attach it to the back of your item or the front exterior of a car/truck/motor home. Tag must be present at all times.

2019-2020 Winter Storage Rates:

All indoor storage priced at \$12.00/linear foot of space (see measured to quarter-foot). Outdoor storage \$6.00/linear foot. Note that you must measure from the **front of your vehicle or trailer (including hitch) to the very back of your item** so an accurate length for storage can be determined and planned for. Length will be verified at the time of check-in (some items have been previously verified). Failure to measure accurately will not allow us to plan accordingly and storage of your item may be delayed. Extra-wide vehicles in excess of 108 inches wide must add a \$50 surcharge. Thank you in advance for your cooperation.

Items commonly stored with us include: Motorcycles, Automobiles, Travel Trailers, Personal Watercraft, Pop-up Campers, 5th Wheels, Boats, Motor Homes, Trailers

We appreciate all of your past business and look forward to fulfilling your winter storage needs this year and in the future.

DAMAGES: I hold harmless the Outagamie County Fair Association and its agents, officers, employees, directors, and volunteers from any and all actions, claims, liabilities, and actions of liability and/or property damage which in any manner arise or are alleged to arise from any and all activities connected directly or indirectly with the storage of my watercraft and/or vehicles with the OCF.

AGREEMENT: I agree that I will abide by all the rules and regulations of OCF. **If I prepay for an inaccurate length, I agree to be billed \$17/foot for the additional length.**

DATES SUBJECT TO CHANGE: I acknowledge that the storage IN date and the storage OUT date may change due to unforeseen circumstances and my stored item will be inaccessible until all stored items can be removed.
