- The **entire rental fee is required 5 working days prior** to the event.
- The renter is responsible for all damages to the property and/or its contents.
- The renter must provide a **short-term \$1 million liability insurance policy** that is in effect for the duration of the rental contract.
- The facilities are to be left in satisfactory, “as is” condition.
- Any damage or clean-up will result in maintenance billing, claim on the insurance policy, and the loss of your group’s privilege to use the facility in the future.
